VENDOR RULES & REGULATIONS

RIVERTOWN HOLIDAY MARKET: The Santa's Market hours will be 6pm-9pm, Thursday-Sunday, November 30th – December 21st. **The 21st will have no booth fee only if you have purchased all 3 weeks.** Santa's Market is an outdoor show that will be held at the Town Green, located at 200 Laurel St in beautiful downtown Conway, South Carolina. This outdoor show is designed as a holiday gift show to provide vendors offering quality arts/craft items a location to sell their products or to promote their business for the holiday season. This shopping event features specialty merchants from across the country offering unique gift items. The Santa's Market includes merchants selling everything from clothing, jewelry, and handbags to specialty art, crafts and children's items.

- 1. APPLICATION PROCESS:** Submission of this application does not guarantee a space. Applicants must submit (*with application*) at least two (2) photos of the items that will be available for sale in their booth. No application will be accepted without the complete application, photos and fee. If your application is not approved, your check will not be cashed and it will be returned. Once you have been accepted as a vendor, **NO REFUNDS** will be issued for any reason. **Application deadline is October 6, 2023 or until spaces are full.** A confirmation will be sent via email.
- 2. RESTRICTED ITEMS:** Food and beverage items such as sandwiches, soft drinks and water may not be sold. Specialty food gift items will be approved on a case by case basis. Music may not be played from individual booths. We reserve the right to remove any items that have not been screened, are of poor quality or inappropriate. **The following items are banned from sale: Any type of animal or pet, snap-N-pops, cap guns or rockets, disappearing ink, crazy foam or silly string, stink bombs, water and marsh mellow guns, knives, guns and/or any other weapons (including replica weapons).**
- 3. SPACE ASSIGNMENTS:** Spaces are 10' x 10'. Booths will be assigned in advance. Exhibitors will not be able to extend beyond the 10' x 10' space. Isles must be clear at all times. Vendors will receive map at set-up. Staff will be on hand to assist with any questions you may have. If you need more than the allotted 10' x 10' space for display, you must purchase another space in advance. Spaces may not be sublet.
- 4. BOOTH APPEARANCE:** All booth should be attractive and have a holiday theme. Tables must be covered and draped to the floor. Boxes and overstock should not be visible at any time. Please keep your display neat and free of trash. Vendors must bring all necessary displays, tables, and chairs.
- 5. ELECTRICITY:** Electricity is available on a very limited basis, at limited locations. If you have a need for power, please mark this on the application and pay the appropriate fee. The electricity fee is **\$25.00 per space.**
- 6. SET UP:** Vendors **may begin their set up** on November 30th, December 7th, December 14th and December 21st for the weekend. All set up must be completed no later than 4:00pm on those days. If you arrive late, your space may not be available. Set up is not allowed after the event has started.
- 7. CLEAN UP:** You are expected to leave the area you occupy as you found it prior to set up. Please dispose of your trash in the provided trash cans.
- 8. NO EARLY BREAK DOWN:** The breakdown of displays and vendor booths is not allowed **until the Market closes at 10pm.**
- 9. NOTICE:** Conway Parks and Recreation reserves the right to **ACCEPT** or **REJECT** any application. We also reserve the right to remove any vendor that does not follow the rules and regulations as established for this event.
- 10. TAXES:** As the vendor, you are responsible for collecting and reporting South Carolina sales tax as required by law.
- 11. NO SHOWS:** Vendors accepted into the Market who fail to participate without giving a 48 hour written notice shall NOT be eligible to participate in future events promoted by Conway Parks and Recreation
